Subject: Completion notice - PR24 scope of services

Dear Caroline

We have completed the scope of assurance that you requested for South Staffordshire Water's PR24 plan and the results are available to you in our individual and overview reports. The scope of our services included:

- 1. Enhancement cases. For each case we reviewed the evidence for the driver and its appropriateness for classification as enhancement, the nature of the solution and the selection process, the expected benefits, the costing approach and benchmarking, and the scale and timing of the solution. We did not review the SEMD case as it was not material.
- 2. The Long-Term Delivery Strategy. We reviewed this at an early stage of its development against Ofwat's requirements in *PR24* and beyond: Final guidance on long-term delivery strategies (Ofwat, April 2022).
- 3. Base cost. We reviewed the documented approach for the derivation of base cost, benchmarking, indirect cost, risk, corporate overhead and opex.
- 4. The process for identification of needs, optioneering and optimisation for the capital plan. We reviewed this against good practice including Ofwat's Asset Management Maturity Assessment.
- 5. Price Control Deliverables. We peer reviewed these with reference to Ofwat's guidance *IN 23/05* and our professional judgement of good practice.
- 6. Metering deliverability. We reviewed the deliverability document as of Friday 25th August 2023. We provided 'critical friend' informal feedback by holding a discussion with the team and providing recommendations to strengthen their assessment of deliverability.
- 7. Customer Engagement. We reviewed the customer engagement line of sight for the enhancement cases and the five key areas for Ofwat.
